General Instructions for NIH and Other PHS Agencies

In the Program Descriptions section, it clarifies that NIH will accept and consider SBIR and STTR grant applications in any area within the mission of the awarding Components - that is the Institutes and Centers, or ICs, identified in the Omnibus Solicitation. Unlike other agencies that often designate unique topics for the SBIR or STTR program - all NIH topics can be addressed using either the SBIR or STTR program.

Confusing NIH and other Small Business Innovation and ...

NIH is required by the law to notify the funding decisions on the SBIR/STTR applications within 12 months. Even though you knew your application was not going to be funded, NIH still needs to send out the notification within 12 months. The decision on an earlier application does not influence the funding consideration of later submissions.

SBIR/STTR FAQs / NIAMS

SBIR/STTR grant applications are accepted in most of the scientific areas for which the Institute provides support. Specific topics of research interest to NIGMS can be found here [PDF]. The NIGMS SBIR program like the vast majority of NIGMS-funded research is investigator-initiated.
